 - Small (2-6 members) will be \$20 for District and \$22 for Regional & State
 - Medium (7-12 members) will be \$38 for District and \$40 for Regional & State
 - Large (13-18 members) will be \$56 for District and \$58 for Regional & State
 - Vocal
 - Small (2-4 members) will be \$14 for District and \$16 for State
 - Medium (5-9 members) will be \$29 for District and \$31 for State
