- \* The OSSAA reserves the right to re-air your broadcast at a later date. A video copy and/or link must be provided upon request.
- \* The OSSAA and/or NFHS Network may restrict certain games or levels of playoff contests from being broadcast.
- \* All approved video live streams must be free of charge and **not on a pay-per-view**.
