

OSSAA REGISTER TO WIN PROMOTION

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Gateway Banking & Mortgage OSSAA Football State Championships Register To Win Promotion (the "Promotion") starts on November 19, 2024 at 12:01 a.m. Central Time ("CT") and ends on December 5, 2024 at 11:59 p.m. ET ("Promotion Period").

ELIGIBILITY: Promotion is open to legal residents of the 50 United States and the District of Columbia, who are 13 years of age or older. Employees of Gateway Banking & Mortgage, ("Promotional Participant"), Teall Properties Group ("TPG"), and each of their respective parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate families (spouse and parents, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter or win.
