EDUCATION-BASED ACTIVITY PROGRAMS

The National Federation of State High School Associations and the Oklahoma Secondary School Activities Association recognize the numerous potential benefits of participation by students in education-based activities. While education-based activities may differ between the stakeholder groups, all should be centered on optimizing the students' scholastic activity experience. Students will change, develop and expand abilities over time; coaches, administrators, and parents should not only be cognizant of the fluid process but also foster a safe, positive environment in which development can occur. Education-based activities must always be viewed as an evolving and unpredictable path.

The NFHS and the OSSAA recognize the influential role played by coaches and directors in all activities, and therefore emphasis should be placed on those individuals to instill and reinforce fundamentals and best practices, not only to minimize risk but also to promote an environment in which a student has the opportunity to reach his or her full potential. The common goal for all the stakeholders involved with education-based activities should be to make the experience enjoyable and rewarding for them all.

While our position is not intended to squelch dreams of achieving a college scholarship or professional or Olympic glory, we do place emphasis on the student's entire scholastic activity experience with the goals of enhancing participation, reducing injury risk, and optimizing performance and success (however defined) during the student's high school career. The ultimate goal: Producing an individual who is competent, confident, connected to his or her peer group and community, and of high character. This essential principle is at the core of the scholastic activity experience and is fundamental to the mission of the OSSAA and NFHS.

I. INTRODUCTION

A. Purpose

- 1. The boys and girls golf manual has been prepared to provide information to coaches and tournament directors and to promote greater consistency in high school golf tournaments throughout the state of Oklahoma.
- 2. The regulations in the manual shall be considered as official interpretation unless the schools are notified of a change by the OSSAA Board of Directors.
- B. Coaches Responsibilities
- To instruct student-athletes as to the OSSAA rules and golf regulations.
- C. Rules Meetings Every head golf coach is required to att

Every head golf coach is required to attend a golf rules meeting sponsored by the OSSAA.

II. SEASON INFORMATION FOR 2025-2026

- A. Tournament Host Request can be found on the OSSAA website (www.ossaa.com). Must be received in the OSSAA office no later than October 24, 2025.
- B. Golf advisory committee meeting to assign tournament sites November 3, 2025, at 1:00 p.m.
- C. Optional Fall Golf Season:
 - The fall season will run from September 1st through October 31st.
 - Participating schools would still adhere to the **9-event** yearlong total (excluding the post-season events and the 3 scrimmage opportunities).
 - Schools/Players would be limited to a maximum of 3 of their 9 events for the fall season (excluding scrimmages).
 - The fall season would be optional and the participating schools' data (IWR) will carry-over into the spring rankings for regional seeding purposes.
- D. Organized practice for Golf may begin no earlier than September 1st and must conclude by October 31st (Fall Season) and may begin no earlier than December 1st (Spring Season). Organized practice is defined as school or anticipated school personnel directly or indirectly giving individual or team instruction concerning the fundamentals of a particular sport.

From the close of the season for Golf to the start date of September 1st, no organized practice in that sport may take place. However, certified school coaching personnel for that sport are permitted to provide instruction in that sport in a physical education class during the regular school day. If a member school does not schedule a physical education class during the regular school day, then an additional period may be scheduled immediately after the close of the regular school day, not to exceed one hour for the purpose of conducting a physical education class, and instruction in a particular sport may be provided by certified school coaching personnel to students during that additional one-hour period. Time spent transporting student participants to an off-site facility or from one school site to another for the purpose of providing instruction in a particular sport during a physical education class or during the one-hour period immediately following the school day shall not be counted toward the time allowed for off-season instruction. The practice period shall begin immediately upon the arrival of the athletes. Golf season opens (date of the first contest) - March 1, 2025

E. Teams and/or individuals are limited to not more than:

- 1. Nine (9) regular season contests. No more than two contests weekly may require loss of instructional time and no more than seven total loss of instructional days. *Please note that virtual learning days do not count as loss of instructional time.
- 2. Six (6) regular season contests for junior high. No more than 4 with loss of instruction time.
- 3. A 9th-grade student may not participate in more than a total of 9 regular season contests if he/she is participating on both the junior high and high school team.
- 4. A nine (9) hole event that requires no loss of school time shall not be counted against the maximum number of contests allowed for junior high and high school.
- 5. Schools may participate in a maximum of three Dual 18-hole events or Tri scrimmages as long as no instructional time is lost.

B. Entry Form

The golf entry form must be entered at www.ossaarankings.com by March 31, 2026, for all classes. A team's line-up can be changed, right up to the day of the tournament.

- C. Entry Fees
 - It is not necessary to send an entry fee with the entry form as your school should have included the golf fee in the total service 1. fee paid in October.
 - If the entry fee was not included in the total service fee, please send the entry fee to the OSSAA office before March 26, 2026, 2. for all classes.
 - 3. Schools/Individuals who qualify for the State Event will pay \$33.00 per player / per 18 holes played for the event. This fee will be billed directly to schools after the State Event.
- D. Weekly Eligibility

A student's current scholastic eligibility status would not change if an OSSAA playoff contest was delayed into the next week due to inclement weather or other extreme circumstances.

- E. Team Members
 - A team may have five members but not less than four members. When five members are playing on a team, the best four scores 1. per eighteen holes will be used.
 - Schools with fewer than four players shall compete for the individual championship only. 2.
- F Regular Season Tournament guidelines
 - All OSSAA sanctioned events must use the digital scoring app (Iwanamaker). 1
 - 2. All regular season events will be a max score of **Double Par.**

G. Regional Tournament

- The OSSAA will provide a regional guidebook that specifies yardages, rules, and guidelines for the regional events. a) Regional Qualifying Standard (IWR Ranking for the season). The ranking will be derived from the season events played b) for each school (fall and/or spring).
- 6A = 2 regional sites Top 20 teams/Top 12 Individuals (not on a team) qualify to attend regionals.
- *Top 6 Teams and Top 6 individuals per regional site advance to State. Ties for six also advance.
- 5A = 2 regional sites Top 24 teams/ Top 15 Individuals (not on a team) qualify to attend regionals.
- *Top 6 Teams and top 6 individuals per regional site advance to State. Ties for six also advance. 4A = 3 regional sites - Top 30 teams/ Top 20 Individuals (not on a team) qualify to attend regionals.
- *Top 4 Teams/top 4 individuals per regional site advance to State. Ties for fourth also advance.
- 3A = 4 regional sites Top 36 teams/ Top 36 Individuals (not on a team) qualify to attend regionals. *Top 3 Teams/top 3 individuals per regional site advance to State. Ties for third also advance.
- 2A = 4 regional sites Top 48 teams/ Top 36 Individuals (not on a team) qualify to attend regionals.
 - *Top 3 Teams/top 3 individuals per regional site advance to State. Ties for third also advance.

* For an athlete to compete as an individual at Regionals, they must have played in a minimum of 3 18-hole events.

** A team can qualify to compete at Regionals as the "Team" as long as the team has been represented in a minimum of 5 18-hole events. The players who comprise the team do not have a qualifying number of events that they must play in to represent the team. An individual that is playing as part of a team but has not played in at least 3 - 18-hole events, is not eligible to qualify as an individual for the State Tournament.

If a school qualifies for regionals or state as a team, but unable to compete, team members will be permitted to play as individuals. H.

I. Violation of Contest Limits (teams and/or individuals)

Generally, if the contest, meet, or tournament limits for a particular activity have been exceeded, by either a school team or by individual participants from a school, the following sanctions will be applied:

- a) The head coach in that activity shall be suspended from coaching in any regular season contests, at the same level, in the same activity, for the remainder of the current regular season and any championship playoff events for that school year.
- b) The head coach in the activity shall be suspended from coaching any regular season contests, at the same level, in the same activity, for one-half of the regular season the next school year.
- c) The school will not be allowed to host any playoff contests in that activity during the school year in which the violation occurred.
- d) The program will be placed on warning for a period of one year.
- J. Off-Season Tryouts

a) Only students attending school in the district for which the try-out is held may be permitted to participate in a try-out. Tryouts should only be conducted for the purpose of the selection of a school team and may not be used for practice time. Each day of the try-out may be up to 2 hours in length. No off-season try-out will be approved for more than three days, and all sessions of the try-out must conclude by 9 p.m. A record of all try-outs should be kept on file at the member school. The OSSAA reserves the right to request try-out forms from a member school. Exception: Cheerleading is exempt from the try-out policy.

K. Awards

- 1. Regional Tournament
 - a) Medals will be awarded to first, second, third, and fourth place individuals and a trophy will be awarded to first place teams.
 - b) In case of a tie (individual), a sudden-death playoff will determine who shall receive the award for 1st place. For Team tied for 1st, the 5th bags score will determine the tie break. If that doesn't break the tie, then the tie will be broken by the best score on the #1 handicapped hole.
- 2. State Tournament
 - a) The tournament medalist will be awarded a plaque and a medal.
 - b) Medals will be awarded to the top ten individual winners.
 - c) Medals will be awarded to members of the teams winning first, second, and third places.
 - d) A championship and runner-up trophy will be awarded to the first and second place teams.
 - e) In case of a tie for individual (Top finisher only) a sudden death playoff will determine who receives the award. Teams tied (for 1st, 2nd or 3rd) will go to a sudden death play-off.
 - f) Coaches' achievement plaques will be awarded to the coach of the team champion and runner-up.

V. CHAMPIONSHIP GOLF SERIES

- A. Régional Tournement Format
- 1. Boys and Girls (6A-5A)
 - a) When feasible, an approximately equal number of teams and individuals will be assigned to regional tournaments based on both geography and competitive balance.
 - b) Will consist of 36-hole (Boys) tournament (beginning at 8:00am) and 18-hole tournaments (Girls) beginning at 8:00 a.m. There will be a coaches' meeting at 8:00 a.m.

* For an athlete to compete as an individual at Regionals, they must have played in a minimum of 3 - 18-hole events.

** A team can qualify to compete at Regionals as the "Team" as long as the team has been represented in a minimum of 5- 18-hole events. The players who comprise the team do not have a qualifying number of events that they must play in to represent the team. An individual that is playing as part of a team but has not played in at least 3 – 18-hole events, is not eligible to qualify as an individual for the State Tournament.

- c) The tournament director shall determine the regional pairings in threesomes.
- d) The event can either be a shotgun or double tee start for the boys and the tournament director for the Girls shall determine whether to use a double tee start (#1 tee and #10 tee) or may also use a shotgun start.
- e) The state tournament pairings formula will be used in determining regional pairings.
- f) Individual participants shall be paired by the regional tournament director.
- g) The final judgment of regional pairings shall be the responsibility of the tournament director.
- h) The Regional tournament results are to be emailed to the OSSAA office, local newspapers and media outlets (no later than noon the day after the tournament) by the tournament director, giving the order of finish of qualifiers for the state tournament.
- 2. Suspension and Resumption of Play In the event a regional tournament cannot be completed on the day scheduled due weather or unplayable course conditions, a winner will be determined if the boys have played a minimum of the same 18 holes and girls have played a minimum of the same nine holes. If play is suspended, a player should mark his/her ball and play should be resumed under the direction of the tournament manager. Weather and course management permitting, every effort should be made to get in the required number of holes to qualify as an official tournament. If weather and/or course conditions will not allow continued play after the suspension, the tournament director shall contact the OSSAA Director of Golf to arrive at a scheduled make-up date.
- C. State Tournament Format
 - 1. Boys (All classes)

- b) The tournament director will set pairings based on the OSSAA post-season pairing formula.
- A double tee start (1 and #10) will be used for all rounds unless weather or course conditions are a factor and the tournament c) director may elect to use a shotgun start.
- d) There will be a coaches' meeting at 7:00 a.m.
- e) The tournament will begin at 8:00 a.m.
- Due to weather or other unforeseen problems, the OSSAA may adjust tournament format. f)
- Team Personnel substitutions may be made between the Regional and State tournament. A coach may substitute a player g) for any reason if the tournament director and/or rule chair is notified of the substitution at least 10 minutes prior to that team member's 1st round starting. - 2. Girls (All classes)
 - Will consist of a 36-hole, two-day tournament. Eighteen holes will be played each day. a)
 - b) The tournament director will set pairings based on the OSSAA post-season pairing formula.
 - A double tee start (1 and #10) will be used for all rounds unless weather or course conditions are a factor and the tournament c) director may elect to use a shotgun start.
 - d) There will be a coaches' meeting at 7:00 a.m.
 - The tournament will begin at 8:00 a.m. e)
 - Due to weather or other unforeseen problems, the OSSAA may adjust tournament format. f)
 - g) Team Personnel substitutions may be made between the Regional and State tournament. A coach may substitute a player for any reason if the tournament director and/or rule chair is notified of the substitution at least 10 minutes prior to that team member's 1st round starting. No substitutes may be made after the 1st round begins.
 - h) The tournament director must email tjohnson@ossaa.com the state results the morning after the finals.
- 3 Suspension and Resumption of Play – Day (1) and day (2) of the tournament
 - In the event play is suspended, the players are to immediately mark their position and leave the course under the evacuation a) plan provided by the tournament committee.
 - When play is resumed, the players are to return to their marked positions and proceed. b)
 - In the (pre-tournament) coaches' meeting, all coaches will be informed in advance of the tournament how many holes the c) course management will allow being played on the second day.
 - Tournament format if 36 holes are allowed to be played on the second day of the State Tournament (Boys) d)
 - (1) If less than 9 holes are played by all participants on day one of the tournament, all scores and penalties will be void. (2) If 9 holes or more are played by all participants on day one of the tournament, then all scores will count, and play will resume on the second day from the point where play was suspended.
 - (3) If play is halted on the first day, the Tournament Director will call a coaches meeting to inform coaches of the format for day two. Starting time on day two will be set and all scorecards will be picked up from day one.
 - (4) If the second 18-hole round of day one was not completed, it must be finished before the final 18 hole round scheduled for day two can be started.
 - (5) The Tournament Director will determine the format for the second day. Options include double tee start or a shotgun start. Team and individual pairings for the final round will be set by the first round and second round scores.

(6) The first day canceled entirely – The format will be a 36-hole tournament. Round one pairings will be set by golf manual first-day format. Round two pairings will be set by round one scores.

e) Tournament format if 36 holes are not allowed to be played on the second day of the State Tournament (Girls)

- (1) If less than 9 holes are played by all participants, on day one of the tournament, all scores and penalties will be void.
- (2) If nine holes or more are played by all participants on day one of the tournament, then all scores will count, and play will resume on the second day from the point of interruption.
- (3) No format will allow more than 36 holes in one day. Note: playoffs for team or individual titles will be allowed time permitting. In the event a playoff is not possible, co-champions will be declared.
- (4) If day one and day two are rained out, the OSSAA will determine how to proceed.
- (5) If all participants complete 18 holes on day 1, and the next round is suspended, those 18 holes will count toward the 2-day tournament score.

On regional and state tournaments where there are rain delays and tournaments may not be completed, the tournament director, Rules Chair and host professional should contact the state director of golf to arrive at when play should end.

- Ties in team position shall have tee times determined by the fifth score for the second round, then first round, and then flip of a 1. coin.
- 2. Ties in individual positions shall be determined by matching scorecards beginning with the second round with the winner taking the higher seed.
- 3. The order of play for a given team on the second day may be changed once and only involving one position. (Example - switch #1 bag and #2 bag or switch #4 bag and #5 bag but not both). A change of more than one position in the line-up will result in a two-stroke penalty per player involved in switching line-up positions for the round being played. The penalty will be assessed against the team score.

V. GOLF TOURNAMENT RULES OF PLAY Local Rules and Terms of the Competition

The Rules of Golf as approved by the United States Golf Association and R&A Rules Limited govern play. These Local Rules and Terms of the Competition are in effect at all OSSAA sanctioned golf events. See applicable Notice to Players or Supplementary Rules for modifications or additions to these Local Rules and Terms of the Competition. Complete text of the Rules and Local Rules may be found in the Official Guide to the Rules of Golf, effective January 2024.

**Unless otherwise noted, the penalty for breach of a Local Rule is the general penalty. **

Method of Play A.

All events will be either match play or stroke play competitions. In stroke play competitions, a player's score will be capped at a maximum number of Double par for non-post season events and strokes set at 9 for Regionals and State.

Out of Bounds B.

> Defined by the line between the course-sided points of white stakes and fence post at ground level. A ball that crosses a road defined as out of bounds and comes to rest beyond that road is out of bounds, even though it may rest on another part of the course.

C. Obstructions

Anything artificial except for integral objects and boundary objects.

D. Penalty Areas

Penalty areas are defined as either yellow or red and this affects the player's relief options (see Rule 17.1d). When a penalty area is defined on only one side; it extends to infinity. When the area is connected to the out-of-bounds edge, the penalty area extends to and coincides with the out of bounds.

Ground Under Repair E.

Defined by white lines. French drains are ground under repair.

F Relief From Seams of Cut Turf

If a player's ball lies in or touches a seam of cut turf or a seam interferes with the player's area of intended swing, the player may take relief for a ball in the General Area under Rule 16.1b and for a ball on the Putting Green the player may take relief under Rule 16.1d, however, interference does not exist if the seam only interferes with the player's stance.

- G. White-Lined Area Tying into Artificially Surfaced Road and Paths
- White-lined areas tied into an obstruction are treated as a single abnormal course condition (See Rule 16.1).
- Wood Chips H.
 - Wood chips around bases of trees are loose impediments.
- I. Integral Objects

Include cables, rods, wires, and wrappings when closely attached to trees, artificial walls and pilings when located in penalty areas or bunkers. An exposed bunker liner may be treated as ground under repair, but interference does not exist if the liner interferes only with the player's stance.

Ball Deflected by Power Line J.

If it is known or virtually certain a player's ball hits a power line or pole supporting a power line during play, the player must replay the stroke by playing the original ball or another ball from the spot where the stroke was made (see Rule 14.6). If the player replays the stroke but does so from a wrong place, they get the general penalty under Rule 14.7.

If the player does not replay the stroke, they get the general penalty and the stroke counts, but the player has not played from the wrong place.

K. Penalties in Maximum Score

All penalties that apply in stroke play apply in Maximum Score, except that a player who breaches any of these four Rules is not disqualified but gets the maximum score for the hole where the breach happened: (1) Failure to hole out (Rule 3.3c); (2) Failure to correct mistake of playing outside the teeing area when starting a hole (Rule 6.1b); (3) Failure to correct playing a wrong ball (Rule 6.3c); (4); Failure to correct playing from a wrong place when there is a serious breach (Rule 14.7b). Stopping Play; Resuming Play-Rule 5.7

L.

Model Local Rule J-1 is in effect as follows:

- a. Immediate Suspension (Dangerous situation): One prolonged note of the air horn.
- b. Normal suspension (non-dangerous situation): Three short notes of the air horn.
- c. Resume Play: Two short notes of the air horn.

Note: During an immediate suspension for a dangerous situation, all practice areas are closed until the Committee has declared them open. Players who disregard such closing are subject to disciplinary action.

M. Practice

Prior to and after a round in stroke play, a player may practice on the designated practice area. Rule 5.2b coverage in stroke play is modified in this way: A player may not practice on the competition course before or between rounds. Penalty for breach of Rule, (see Rule 5.2)

N. Use of Caddie Prohibited

A player must NOT have a caddie during the round. (Model Local Rule H-1.1).

O. Transportation

During a round, a player must not ride on any form of motorized transportation except as authorized or later approved by the Committee.

P. Time of Starting

A player is treated as being at their starting point when they are within the designated area of their starting tee. This does not apply to a shotgun start event.

Q. Returning Scorecard

A player's scorecard is treated as being returned to the Committee when they leave the designated scoring area. In the absence of a designated scoring area the team cards are treated as returned when the designated coach returns them to the Committee.

- R. Missing Player or Marker Certification: (Local Rule L-1) "Rule 3.3b(2) is modified in this way: If a player returns a scorecard without the hole scores being certified by the player, the marker or both, the player gets the general penalty (two penalty strokes). The penalty applies to the last hole of the player's around."
- S. Advice Giver
 - 1. Rule 24.4a is modified as follows; A team may name two Advice Givers whom players on the team may ask for advice and receive advice during the round. The team must identify each advice giver to the Committee before any player on the team begins their round. In Rule 10.2b certain restrictions concerning Advice and Other Help apply to the Advice Giver(s).
 - 2. Violation of Rule
 - a) 1st offense Warning
 - b) Each additional offense 2 stroke penalty on player
- T. Pace of Play

In the absence of Rules Officials and in order to complete round(s) in a timely manner, players should be ready to play when it is their turn, and they are encouraged to play "Ready Golf" in a safe and responsible manner. If Rules Officials are available on-site a Pace of Play policy should be instituted.

U. Player Uncertain as to the Correct Procedures (in stroke play only)

If a player is uncertain as to his or her rights during the play of a hole, the player may play two balls, however, the player MUST decide to play two balls when the uncertain situation arises and before making a stroke. Before making a stroke the SHOULD choose the ball to count if the Rules permit and announce the choice to their marker or another player. If a choice is not made in time, the first ball played is the chosen ball by default. The facts MUST be reported to the Committee even if the score with both balls is the same. Failure to do so will result in Disqualification (see Rule 20.1c).

V. Result of the Competition

The competition is final when the trophy has been presented to the winner or, in the absence of a prize ceremony, when all scores have been approved by the Committee.

VI. OSSAA GOLF

A. General Regulations

- 1. Championships shall be conducted according to the Rules of Golf with certain modifications as noted by OSSAA regulations.
- 2. A Tournament Director is to be named by the OSSAA for the regional and state tournaments. The tournament director shall name a Games Committee. The tournament director will appoint the committee prior to the event and notify the OSSAA and participating schools as to who is on the committee. The committee will consist of the chair of the rules committee, tournament director, and the course manager or course professional at the golf course hosting event. The Tournament Director will work with the chair of the Rules Committee to make decisions pertaining to the conduct of the tournament, including, but not limited to, pairings, golf course setup, and rules committee. The Games Committee will make decisions pertaining to protests and suspensions /resumption of play. The Tournament Director shall be responsible to provide the following to Coaches and Players in the event:
 - The <u>"hard card"</u> containing the conditions for competitors will be prepared by the Rules Chair and be made available on the first and 10th tees.
 - <u>Hole location sheets and Pace of Play</u> The Rules Chair will prepare hole location sheets and pace of play sheets. There should be enough sheets at the first and 10th tees each day of the championship. (Evacuation plans should be copied onto the back of the hole-location sheets.)
 - <u>Local Rules Sheets</u> The Rules Chair will prepare the local rules sheet. All local rules should be printed and distributed to all participants and coaches. A sufficient number should be available at the starter's tables #1 & #10 tees each day of the championship.
- 3. A coach must be present at the tournament site.

Golf

Advice Giver - Each school may name two advice givers whom players on the team may ask for or receive advice from during the round. Each team or individual must identify the advice giver(s) to the Games Committee before players on the team or an individual asks for or receives advice from the advice giver(s). The advice giver(s) must be designated by their school to perform coaching duties, wear a Coach Badge (if provided), and be school employees or approved by the school board to serve in that capacity. All advice givers must complete the same assigned courses as that of lay coaches. **AT LEAST ONE ADVICE GIVER MUST BE A SCHOOL EMPLOYEE.** Advice giver(s) must not interfere with pace of play and rights of other players. A team's advice giver must only give advice to, and ask advice from, players on their team and the team's other advice giver and must not ask for advice from any other advice giver or any other outside influence. When a player is competing as an individual, the player's advice giver must only give advice to the player and must not ask advice from any other advice giver asks advice from someone not allowed, the Games Committee may revoke their position.

Note: Advice givers are outside influences and are not treated as part of the player's side. However, a player is responsible for certain actions of another person, including his advice giver, under Rule 1.3c(1). A penalty may apply when:

The player's advice giver takes an action that would breach the Rules if taken by the player and that advice giver does so at the player's request or while acting with the player's authority, such as the player asking the advice giver to stand in a location on or close to an extension of the player's line of play to help the player with his alignment, in breach of Rule 10.2b(4).
The player sees his advice giver about to take an action concerning the player's ball or equipment that he knows would breach a Rule if taken by the player and does not take reasonable steps to object or stop it from happening, such as the advice giver taking an action to improve the conditions affecting the player's stroke, in breach of Rule 8.1a. The Committee trusts that all players and advice givers respect the principle of obeisance to the rules, proper conduct and fair play in the spirit of the game.

5. Coaches are not permitted to play on the course at the tournaments.

- 6. Participants may not use caddies or motorized pull/golf carts during the championship rounds. Non-motorized push/pull carts may be used by a participant at a regional or state tournament. It is up to the school to secure the non-motorized push/pull cart. Any exception to this rule must be granted in writing by the OSSAA. (The OSSAA will apply the standards of the American with Disabilities Act to determine if conditions exist to allow the use of a motorized golf cart.)
- 7. For playoff tournament play, a limit of nine strokes on a hole shall be used. The ball must be picked up after nine strokes to maintain pace of play and may be declared at any time. The nine-stroke rule is solely used to speed up play and shall not be used to avoid disqualification.
- 8. Scoring System

A. Each player will keep score for their marker on the paper score card and on the App.

- B. All scores are to be declared and recorded at the end of each hole before starting the next hole or in the case of the last hole of a stipulated round, before signing the official card.
- C. Any correction must be done before starting the next hole or the signing of the card if the correction is on the last hole of a stipulated round.
- 9. In regional and championship play, boys and girls shall participate on separate teams.
- 10. Substitutions Substitutions for player(s) competing on a team would be permitted at the coach's discretion. Coaches may substitute a player at least 10 minutes prior to that team member's starting time for the first round. The coach must notify the Games Committee prior to the starting time of the player being substituted. Substitutions are not allowed after the start of the first round.
- 11. Appropriate golf attire is required at all times. Appropriate dress may be determined by the local course regulations. Soft spikes or tennis shoes are required.
- 12. Players shall be advised that any conduct that would discredit the team or school will not be permitted. (i.e., profanity, club throwing, acts of defacing the golf course, bullying, intimidation, etc.).
 - a) First Violation warning
 - b) Second Violation disqualification
 - c) The use of tobacco by student-athletes is prohibited during the competition. Any student-athlete who uses tobacco during the competition shall be disqualified for the remainder of the competition.
- 13. Gallery Guidelines
 - 1. Parents, fans, and friends are welcome.
 - 2. Coaches are allowed to communicate and coach their players at all times, provided they do not go onto the green, hold up play or interfere with the other players in the group. Coaches should never communicate with other teams/team members in a negative manner.
 - 3. All other gallery members are advised to stay on the cart trails and not communicate with the players except at the end of 9 and 18 holes. Gallery members should never communicate with other teams/team members in a negative manner.

- 4. The gallery is advised to remain a reasonable distance (30-40 yards) behind all players in the group and are urged to use proper golf etiquette and not move or talk while any member of the group hits a shot or putt. Gallery members should
- 5. Failure to observe this rule may result in stroke penalties or team disqualifications.
- 6. All cell phones should be placed on "silent" or "vibrate" when carried on the golf course.
- 7. IN ORDER TO IMPROVE COMMUNICATION, COACHES ARE ADVISED TO COMMUNICATE THIS MESSAGE TO THEIR PLAYERS AND THE PLAYERS TO THEIR PARENTS, FANS, AND FRIENDS.
- 8. Violation of Gallery Rule
 - a) 1st offense warning
 - b) 2^{nd} offense and beyond -2 strokes penalty on player
- 14. The OSSAA suggests that players be informed that they have the right to stop play if they think lightning threatens them, even though the committee may not have specifically authorized it by signal.
- 15. Scorecards For OSSAA sanctioned tournaments, scoring/scorecards shall be kept in strict accordance with Rule 3.3b of the USGA's "Scoring in Stroke Play." The scorecard has been returned when the player submits their card to an official and leaves the designated scoring area. Only officials and participating players are permitted in the designated scoring area. Note: Player may consult with designated coaches without undue delay until they submit their scorecard. Coaches are not allowed in the scoring tents. A daily team score is computed by totaling the lowest scores of four of the five team members. The final team score is determined by totaling each daily score. If scorecards are collected by a team's coach for the purpose of returning to the Committee, scorecards are considered final when the coach turns scorecards into the Committee.
- 16. Scoring The player's score is kept on his or her scorecard by the marker who is identified by the Committee or chosen by the player in a way approved by the Committee. The player must use the same marker for the entire round unless a change is approved by the Committee either before or after it happens. After each hole, the marker should confirm the number of strokes and penalty strokes the player took on the hole and enter the score on the player's scorecard. When the round has ended, the marker must certify the hole scores on the players' scorecard and sign the scorecard.

The player should then carefully check the hole scores entered by the marker and raise any issues with the Committee. The player must make sure the marker certifies the hole scores on the scorecard. The player must not make any changes to a hole score except with the markers 'agreement or the Committees approval. The player must certify the hole scores, sign the scorecard, and promptly return it to the Committee after which a player must not change the scorecard. If a player breaches any of these requirements, he/she will be disqualified.

17. Scoring Procedures - The paper scorecard will be signed by all players in the group and turned into the scoring table after the event and will serve as the official scorecard for the event.

The hole-by-hole scoring process:

- 1. Each athlete will serve as the marker for their pairing partner.
- 2. At the end of each hole, the marker should enter the score on the app and on the paper scorecard. This process should take place before the pairing tees off on the next hole. If there is a discrepancy in the score for that hole, the pairing should resolve the issue before teeing off on the next hole.

Attesting the scorecard at the end of the round

After the round, the group will compare the digital scorecard with the paper scorecard. If there is a discrepancy between the digital scorecard and the paper, the pairing will have to agree with what the score should be for that hole. After consensus is reached, the marker will change the digital score and then the players can attest the scorecard. If the marker is unable to go back and amend the score, the meet manager at the score table will make the adjustment, and the player and marker can then attest the scorecard. If the two cards match, the players will digitally attest the scorecard and then sign the paper scorecard (both the player and marker will sign each scorecard) and turn in the paper cards to the scoring table.

18. Tie-Break Procedures Individual and Team Tie-breaking Procedures Teams:

Ties shall be broken during a sudden-death playoff counting low four scores. If there are two or more teams involved in a playoff, the shotgun format listed below will be used. The games committee will determine the sequence of holes. The team playoff will be conducted first if any players involved would also be in a playoff in the case of a tie for individuals advancing. Sudden-Death Playoff Procedures:

Teams will draw for positions. For a two-team playoff, the winner of the draw shall have the option of the A or B positions set forth below. For a playoff involving more than two teams, the teams shall assume the drawn letter position (A, B, C, etc.) set forth below (Refer to NOTE 1).

Two teams (A and B; tee off alternately)

 $\#5A\ \#5B\ \#4A\ \#4B\ \#3A\ Playoff\ Hole\ \#1$

 $\#3B\ \#2A\ \#2B\ \#1A\ \#1B\ Playoff\ Hole\ \#1$

SHOTGUN FORMAT: If a shotgun start is necessary, the scoring procedure will be the aggregate low four scores until a winner is determined.

Two teams

Hole #1 = Team A - Players #1, # 2, 3; Team B Players #1 and #2

Hole #2 = Team A - Players #4 and #5; Team B - Players #3, #4, #5

To determine which team has the honor, Team A #1 player will hit first with all other players alternating (Ex: Team A #1, Team B #1, Team A #2, Team B #2, etc.)

Coaches will have the ability to determine starting hole assignments for their players. The format in pairings for a playoff of six teams or more shall be consistent with the foregoing format as determined by the games committee.

Non-Sudden-Death Tie-Breaking Procedure: For pairings purposes and for situations in which a sudden-death playoff cannot be completed, the following system shall be used to break ties, except as provided elsewhere when ties need not be broken.

Teams

First tiebreaker – cumulative total of the non-counting scores.

Second tiebreaker – cumulative total of the lowest player score from each round.

Third tiebreaker - cumulative total of the second lowest player score from each round.

Fourth tiebreaker - cumulative total of the third lowest player score from each round.

Fifth tiebreaker - cumulative total of the fourth lowest player score from each round

Sixth tiebreaker - revert to original seeding of teams. Individuals (within a team)

When a tie exists within a team

The individual with the lowest team position at the beginning of the tournament will be given the later tee time.

- Individuals (not within a team)
- 1. Low score of the most recent round.
- 2. Low score next previous round.
- 3. Revert to original seeding of individuals.
- 19. Warm-up before playoff: all contestants will be allowed a reasonable amount of warm-up time before a playoff begins.
- 20. The ball that is hit off the tee box will remain in play until the ball is holed out or the hole completed unless lost or damaged.
- 21. It is recommended in all OSSAA sanctioned events that the ball be played down according to (USGA Rules). However, the site manager (tournament director) may decide the ball be played up within one grip-length everywhere except hazards no closer to the hole. The ball may be lifted, cleaned, and placed within 1 grip-length of its original position not closer to the hole. The ball is in play once it is placed on the course. The ball may be lifted only once. Procedure: The Original position of the ball must be marked prior to lifting the ball. The ball must be lifted by hand (not with the club). Once the ball has been replaced, the marker may be removed. A player may not move his/her ball from off the putting surface onto the putting surface, nor may they move their ball while on the putting surface.
- 22. All students who are entered must be eligible by the Oklahoma Secondary School Activities Association Rules and Regulations.
- 23. The Golf Advisory Committee will meet in the OSSAA office <u>November 4th, 2024</u> at 1:00 p.m. for the purpose of recommending site selections for the playoff tournaments for the 2025 season, to the OSSAA staff.
- 24. A student is not eligible to participate in any golf tournament in which he or she has used their knowledge or skill for financial gain. Neither can they be a part of a team in which their score counts in competing for money or other monetary compensation. (Allowable travel, meals, and lodging expenses may be acceptable) A student may receive trophies, medals, and plaques as awards in tournaments.

25. EMERGENCY ACTION PLAN

Any time a member school is hosting a planned activity at a school facility there must be an Emergency Action Plan in place. The plan must be shared with any visiting school. An Emergency Action Plan, or EAP, is a formal written plan, developed by the host site, that identifies potential emergency conditions at the event site and prescribes the procedures to be followed to minimize or prevent loss of life and property.

VII. PRE-EVENT PLANNING

- A. Securing the Proper Facilities
 - 1. Have an inclement weather plan.
 - 2. Tournament scheduler should avoid playing while other golfers are on the course.
- B. Pre-Tournament Sessions
 - 1. Determine the number of teams or players using the course.
 - 2. Set date and time of event--including rain date.
 - 3. Set green fees, if applicable or entry fees.
 - 4. Determine pairing arrangements.
 - 5. Announce any measures to be taken to speed play.

- 6. Awards to be given.
- C. Preparation of Tournament Forms
 - 1. Information sheet for players and coaches--consisting of:
 - a) Pairings.
 - b) Starting time.
 - c) Rules
 - (1) Names of rules committee members.
 - (2) USGA and OSSAA rules.
 - d) How to play hazards.
 - e) Hole out all putts.
 - f) Check before signing scorecards.
 - g) Responsibilities of players
 - (1) When and where to turn in scores.
 - (2) Maintaining less than a hole distance between groups.
 - h) Playing etiquette. There are certain Do's and Don'ts every contestant should follow so that everyone's game will be made just that much more enjoyable and will promote a smoother pace of play.
 - 2. Reminder to all Contestants
 - a) Do replace divots and repair ball marks.
 - b) Do keep bags off the green.
 - c) Do delay hitting until you are sure those ahead are well out of range.
 - d) Do play without undue delay. Be prepared to hit when your turn comes.
 - e) Do let the player farthest from the hole play first.
 - f) Do follow the trajectory of balls hit, establishing markers if ball is in rough.
 - g) Do smooth out footprints and club depressions in bunkers, after the ball is out of the bunker.
 - h) Do allow the player to have the honor to play first.
 - i) Don't disturb players with unnecessary noises.
 - j) Don't stand in a position that interferes with a putt, a shot, or the concentration of a fellow contestant.
 - k) Don't tally scores on the greens.
 - 1) Don't take excessive practice swings that will annoy other players.
 - m) Don't practice putting on the greens or the course during the day of the tournament.
 - 3. What to do in case of lightning: If you are called off the course, have evacuation procedures to be followed.
 - 4. Awards: Open immediately upon receipt to check for breakage. Call the OSSAA office if there are any problems.
 - 5. Name and phone numbers of local restaurants and hotels, if necessary.
 - 6. Scorecards
 - a) It is required at the playoff tournaments and recommended at all other sanctioned events, every player will keep the score of all players in the group and all scores will be declared and recorded at the end of each hole.
 - b) At the completion of the designated round, all players are to sit together with a tournament official to go over all cards. One of the cards will be chosen by the official to be the official scorecard to be signed by all contestants.
 - 7. Other Publicity
 - Anything you feel is appropriate to the smooth running of this event.
 - 8. First Aid (emergency care procedure)

VIII. CONDUCT OF EVENT

- A. Equipment and supplies
- B. Review Rules

By the pro or tournament director five or ten minutes before the start of the meet--all pertinent rules should be discussed with the contestants and an opportunity to be given for questions to be asked. One of the calculated risks coaches must accept is that he/she, his/her players, or the officials may make mistakes during the course of the game or contest. The Board of Directors has established a policy of not honoring a protest based upon a rule situation, nor a situation which involves judgment on the part of the game official.

- C. Rules Committee
 - 1. Identify various members so participants know who to bring their questions to.
 - 2. Probably best to let the local professional be the final arbitrator in any dispute.
- D. Meet Marshals
 - 1. You may find it advantageous to assign one or two meet marshals (coaches or faculty).
 - 2. Their job is to patrol the course, keeping players moving at a comfortable pace throughout the course.
- E. Starters

If contestants are going off both one and ten tees--a responsible person (faculty member or coach) should be there to assure the right contestants are teeing off and they introduce themselves and identify the ball they are playing.

- F. Scoreboard
 - 1. Assign competent people.
 - 2. Players shall report scores at the end of the round.
- G. Awards Presentation

X. COACHES' ETHICS AND PROFESSIONAL STANDARDS

- A. Exemplify the highest moral character, behavior, and leadership.
- B. Respect the integrity and personality of the individual athlete.
- C. Abide by the rules of the game in letter and in spirit, regardless of the consequences.
- D. Respect the integrity and judgment of sports officials, never baiting or taunting officials in any way, or seeking out an official during halftime or at the conclusion of a contest.
- E. Demonstrate a mastery of and continuing interest in, coaching principles and techniques through professional improvement.
- F. Encourage and respect for all athletes and their values.
- G. Display modesty in victory and graciousness in defeat.
- H. Promote ethical relations among coaches.
- I. Fulfill responsibilities to provide emergency health procedures and ensure an environment free of obvious safety hazards.
- J. Encourage the highest standards of conduct and scholastic achievement among all athletes.
- K. Seek to inculcate good health habits, including the establishment of sound training rules.
- L. Strive to develop in each athlete the qualities of leadership, initiative, and good judgment.
- M. Achieve a thorough understanding and acceptance of the rules of the game and the standards of eligibility.
- N. Any time a coach who does not hold a valid Oklahoma teaching certificate (lay or volunteer coach) is ejected from a contest for unsportsmanlike conduct, including but not limited to arguing a call, language or gestures directed toward a game official, he or she will be required to complete the NFHS Teaching and Modeling Behavior course within seven (7) days of the ejection, the course can be found at NFHSLearn.com. Additionally, personnel not holding a valid Oklahoma teaching certificate must meet with a representative of the OSSAA prior to being reinstated to coach the school team. A school administrator will also be required to attend the meeting.

XI. PUBLIC CRITICISM

Any school representative who publicly criticizes a contest official, or members of the OSSAA Staff or Board of Directors and any contest official who publicly criticizes a school representative, or members of the OSSAA Staff or Board of Directors in connection with a contest, meet, or tournament is subject to sanctions. The member school represented by an individual who publicly criticizes a contest official may also be subject to sanctions if the school fails to take appropriate action in response to the school representative's public criticism of the contest official. The sanctions could include warning or suspension.

Public criticism includes, but is not limited to, comments made to the media or during a broadcasted event, and comments made in a public forum.

XII. NOT HONORING A PROTEST (BOARD POLICY XLVIII)

A. OSSAA will not consider requests to overturn the determinations of game/contest officials in interpreting or enforcing rules at games or contests. In agreeing to participate in a game or contest, a member school, and the individual participants and the coaches or sponsors representing that member school, accept the risk that game/contest officials may make errors in interpreting or enforcing rules at games or contest. Any errors by game/contest officials should be raised with those officials, in a respectful manner, and in accordance with the rules established for that particular activity. The decisions of the game/contest officials are accepted as final.

An exception to this policy may be granted if in the case of an ejection of a participant from a contest, the game/contest official misidentifies the individual who should have been ejected. The request to review the misidentified player must be submitted to the OSSAA in writing.

XIII. CONDUCT OF STUDENTS

- 1. Please refer to Rule 4 in OSSAA Rules and Regulations Handbook located in the principal or athletic director's office concerning the conduct and fighting rule.
- 2. It is mandatory that all head coaches remind his/her team that fighting during the post-game hand shaking ceremonies or conducting themselves in an unsportsmanlike manner after the game will be severely penalized. The head coach and team will be subject to additional suspension penalties beyond the normal penalties imposed on fighting and unsportsmanlike acts that occur during the contest. Injuries have occurred because of fans climbing over walls and fences, being trampled, or partaking in dog-pile celebrations, etc. At the conclusion of a contest. Therefore, school administrators should be aware that if their student body and fans come onto the playing area after a contest, penalties may be imposed.

XIV. VIOLATIONS OF CONSTITUTION, RULES, REGULATIONS OR OSSAA POLICIES

1. When a violation of OSSAA's Constitution, Rules, Regulations, or Policies has been determined to have occurred, the Executive Director is authorized to impose sanctions or remedies, which may include suspending a coach or other school personnel from coaching and/or activity program management responsibilities, or imposing limits or conditions on those coaching and/or activity management responsibilities.

XV. HAZING

Hazing incidents have no place in the activity programs of our member schools. The OSSAA encourages each member school to develop procedures to inform their students that this type of behavior is not acceptable and should not be tolerated.

XVI. TAUNTING

Any form of taunting which is intended or designed to anger, bait, embarrass, ridicule, or demean others is subject to penalty.

XVII. SUMMERTIME DEAD PERIOD

The dead period will occur during the week in July, which includes the 4th of July each year. The dead period will be nine (9) days in length and begin the weekend preceding the 4th of July and the weekend following the 4th of July.

Secondary-level students enrolled or pre-enrolled at a member school may not use any member school's athletic facilities during the dead period in connection with any athletic activity governed by the OSSAA. Member school coaches, assistant coaches and sponsors may not have any contact with secondary level enrolled or pre-enrolled students in that member school in any athletic activity governed by the OSSAA for the purpose of coaching, training, or instructing.

Summertime policies, including beginning and end of season restrictions, can be found in OSSAA Board Policy XI in the Administrator's Handbook.

Violations of the summertime dead period policy will result in the coach or sponsor being suspended from the first half of the regular season in that athletic activity. School personnel not designated as a coach or sponsor in violation of the summertime dead period policy will result in the head coach being suspended from the first half of the regular season in that activity.

SUMMERTIME DEAD PERIOD QUESTIONS AND ANSWERS

1. How do I know when the dead period begins and ends each year?

Answer: The dead period will be nine (9) days in length and begin the weekend preceding the 4th of July and the weekend following the 4th of July.

2. Does the Summertime Dead Period Policy cover non-athletic activities?

Answer: No, the Summertime Dead Period Policy only applies to athletic activities that are governed by the OSSAA.

3. Can a coach and a player have any contact during the Summertime Dead Period?

Answer: No, contact between coaches, assistant coaches and sponsors with enrolled or pre-enrolled students for the purpose of coaching, teaching, training, or instructing is prohibited.

4. Can a student participate without the member school coach at member school facilities in an athletic activity during the Summertime Dead Period?

Answer: No, school athletic facilities may not be used by enrolled or pre-enrolled students during the dead period in connection with any athletic activity governed by the OSSAA.

5. Can a member school coach use member school facilities to train, coach or instruct secondary-level students during the Dead Period?

Answer: No, the policy prohibits the use of member school facilities during the Dead Period for the purpose of coaching, teaching, training, or instructing. Field maintenance is not prohibited by the policy.

6. Does the Summertime Dead Period Policy prohibit participation in a National level tournament during the dead period?

Answer: No, the coach and any enrolled or pre-enrolled students who have qualified earlier in the summer for a national level tournament may participate in that tournament.
