- * The OSSAA reserves the right to re-air your broadcast at a later date. A video copy and/or link must be provided upon request.
- * The OSSAA may restrict certain games or levels of playoff contests from being broadcast.
- * All approved video live streams must be free of charge and not on a pay-per-view.

SCHOOL BROADCAST PROGRAMS
